PRIVACY POLICY

Effective Date: 1 January 2024

This Privacy Policy describes how Accelerate Vision 2030 LLC (“Accelerate Vision 2030”) collects, uses, protects, stores, discloses, and otherwise processes information when you visit our website or when you engage our Services (as outlined on our website). Capitalized terms used but not otherwise defined herein shall have the meanings ascribed in the Accelerate Vision 2030 Terms of Use.

1. Categories of Personal Information

We collect the following categories of personal information, as outlined below without limitation, for one or more of the following Business Purposes as further described in Section 2 of this Privacy Policy below:

- **Contact information:** Your full name, email address, and phone number.
- **Identifiers:** Your business information and any other information that may be deemed necessary for us to provide you the requested Services.
- **Financial Information:** Payment details, payment card number, payment card expiration date, and CVV code.
- **Commercial information:** Records of Services obtained or considered.

2. Business Purposes for Collecting Personal Information

We do not sell, share, or outsource your personal information. Below is a list of the purposes for using each category of information (collectively, “Business Purpose(s)”):

- **Transactional Purposes:** We will use your contact information, identifiers, financial information, and inferences to:
 - provide you with any Services under our brand;
 - process payments;
 - send confirmations;
 - communicate with you; and
 - respond to you requests and inquiries.
- **Marketing and Promotional Purposes:** We may contact you to provide information about us and our Services, including personalized marketing communications. You can choose to opt out of marketing communication, as per Section 9 of this Privacy Policy.
- **Develop and Improve our Services:** We may use reach out to you to help us improve and analyze our existing Services.

- **Legal:** We may use your contact information, identifiers, financial information, and commercial information to comply with any legal obligations.
- **Other Purposes:** We may use contact information, identifiers, financial information, and commercial information for other reasons which we will notify you of in advance.

3. Methods of Collecting Personal Information

We collect personal information in the following ways:

- **Directly from you:** We will collect contact information, identifiers, and financial information that you have provided directly to us, including via our online form, phone, WhatsApp, email, or any other method.
- **Automatically:** When you access or use our Services, we may collect identifiers from the Site.
- **From third parties:** We may collect contact information and publicly available identifiers from third parties, including social media platforms or networks, service providers, and public authorities.

4. How We Share Information with Others

We will share personal information in the following circumstances or as otherwise described within this Privacy Policy:

- **Service Providers:** We may share necessary personal information with vendors and service providers who support the operation of our Services and our business, and who need access to such information to carry out their work for us. In some cases, the vendor or service provider may directly collect the information from you on our behalf, as detailed within their respective privacy statements.
- **Affiliates:** We may share personal information with and among our parent company, subsidiaries, affiliates, or their successors or assigns.
- **Government Entities:** We may share information with regulatory and government entities including government, administrative, law enforcement and regulatory agencies; tax authorities; corporate registries; and other public agencies or authorities during the course of providing you Services or to comply with any applicable law, regulation, legal process or other legal obligation. This includes cooperating with law enforcement when we need to do so, obtaining legal remedies or limiting our damages, and to enforce or protect our contracts, legal rights or the rights of others, including by responding to claims which may be asserted against us.
- **Corporate Transaction Recipients:** We may share information with potential investors, purchasers, merger partners, and their advisors in the event we: (i) sell or transfer, or are considering selling or transferring, all or a portion of our business or assets; or (ii) are considering or engaging in any reorganization, conversion, merger, sale, joint venture, assignment, transfer or disposition of all or any portion of our ownership interest, business or operations.

- **With Your Consent or At Your Direction:** We may share your information with third parties whenever you consent to or direct us to enable such sharing.
- **Other Reasons:** We may share information for other reasons we may describe to you in advance.

5. Security

We have implemented reasonable technical, administrative and physical security controls designed to protect personal information. However, we cannot guarantee absolute security and encourage you to use caution as well as protecting your own computer systems with effective antivirus and malware detection software.

6. The Services are Not Intended for Children

We do not knowingly collect or store any personal information from anyone under the age of 13. If we become aware that we have collected or stored personal information from an individual under age 13, we will permanently remove their personal information from our files. If you are a parent or guardian and believe we may have inadvertently collected personal information from your child, please notify us immediately by sending an email to admin@av2030.com.

7. Retention of your Information

We will retain and use your personal information for only as long as is necessary for providing you Services, and in accordance with the applicable laws of data retention. Users of our Services should be aware that de-identified or anonymized versions of information may be retained indefinitely for Business Purposes.

The Services are intended to be supplied from the United States, unless otherwise agreed upon from our partners overseas. If you are using or accessing the Services from outside the United States, please be aware that personal information we obtain about you will be processed in the United States or in other specified jurisdictions as necessary.
